Re: Vote of NO Confidence in the Executive Team

Dear Mayor and Members of the City Council,

On behalf of our represented members of the SEIU Local 721 your employees, we would like to inform you of how the majority of them feel due to the treatment they have experienced over the past year or so, specifically from your Human Resources Department and the executive administrative team. Employee morale is at its lowest and our members don't feel that the Human Resources Manager, Melanie Hanisco, is approachable or has an open-door policy. There have been times when employee have questions and have tried to walk into her office, and they are immediately asked if they have an appointment or her office door is shut, and she is inaccessible. Members feel disrespected and that their voices are being silenced. Many times, concerns are not being addressed and/or members receive an attitude from Mrs. Hanisco. This is a perfect example and a contributing factor to why your city employees feel demoralized.

During these trying times, due to the pandemic, there have been discussions that have impacted our members in a negative way and have created a hostile work environment. Our members have been abiding by the rules and policies yet at the same time, there are members of management not following the proper policies and protocols, such as wearing a mask at all times while walking around indoors. We hope you can address these concerns with the management team and ask that they lead by example.

Our members have continued to maintain the level of customer service and work ethic that is essential for our city to remain "The friendly city by the Sea". Year after year our members, your employees, have worked hard to keep services going with a smile but not without a sacrifice. There are positions that, due to attrition, have not been filed and many of the duties of the employees who have left are placed on our members. Members have been required to take on additional duties and responsibilities of these position vacancies, without compensation and at times requiring our members to work out of class. These issues and concerns have been brought to Mrs. Hanisco's attention and seem to have fallen on deaf ears.
