The method used to select vote center batches and mail ballot batches is similar to that used to randomly draw lottery numbers, in accordance with CA EC 15360 as specified in regulations adopted by the SOS.

Lottery-type random draw using four sets of labeled ping pong balls. One set labeled 0-1 for thousands, three sets labeled 0-9 for drawing numbers representing digits in the precinct or batch number for hundreds, tens, ones.

Description of any discrepancies noted (include details about each discrepancy and how each was resolved; also include anything unusual observed during the manual tally process or anything that may improve the manual tally process):

Zero (0) unresolved discrepancies. All manual tally totals matched the system reports.

There were initially variances on four manual tallies, which upon reconciliation, were found to be due to the completion of necessary adjudication in order to recognize voter intent of votes in those batches. Once ambiguous marks, overvotes and write-in votes were adjudicated, manual counts of vote totals matched adjudicated system reports in all cases. There are no discrepancies.

A manual tally of ballots cast in at least 1% of precincts and batches, selected at random, will be conducted as part of the post-Election Day canvass of this election. The manual tally process, as are all components of the official canvass of results, is open to public observation.

The random selection of precincts and batches to be manually tallied will commence on:

Thursday, November 10, at 10 a.m.

The manual tally of the votes cast on these selected ballots will commence on: **Tuesday, November 15, at 9:00 a.m.**

The manual tally will be conducted each day, until completed, during normal business hours, Monday through Friday, from 8:00 a.m. to 4:30 p.m. If needed, manual tally hours could be extended, including evenings until 8:00 p.m. and/or on weekends and holidays.
